**Phragmites update**

Macomb County Department of Planning & Economic Development in cooperation with the Southeast Michigan Council of Governments (SEMCOG) treated phragmites on the north end of Venetian canal and along road right of way/bike trail on S. River Road. Good news... we should see a significant decrease in new growth this spring. SEMCOG will treat the phragmites annually on all county roads/right of ways. Do not attempt to cut down phragmites, this promotes new growth.
